Presentations will be limited to a maximum of three (3) minutes, with a total of thirty (30) minutes designated for this portion of the agenda.
- E. Questions for the Board. Individuals with questions on school district issues may submit them in writing. The Board will automatically refer requests to the Superintendent, who will endeavor to respond to your questions after the meeting.
- **F. Placing issues on the Board Agenda.** Items from the public pertaining directly to school business may be placed on the Board agenda by submitting the request in writing to the Office of the Superintendent.
